Process Steps



- The Doctor's calendar is constantly monitored to check last minute add on appointments and insurance checks are done on a real time basis
- All information pertaining to the benefits along with other information like coverage and co pay
 expenses are entered into the EHR following a standard format
- Verifications are completed two weeks ahead of scheduled appointment
- The process adhered helped the practice determine patient's eligibility and financial commitments prior to the patients visit
- Patient follow up calls related to insurance were taken over to avoid delays in verification process
- Created ample time for the practice to focus on patient service, have good rapport with patient which lead to healthy revenue channel

Results:

- 95% of insurances were verified before appointment
- Reduced time taken to submit claims by 24 hours
- Achieved 98% accuracy on quality standards
- Reduced denials by 15%
